Duties & Responsibilities

### This is a voluntary position with an initial three-year term.

The Board shares collective responsibility for the organization's strategy and maintains oversight over its activities, ensuring that WCSI remains true to its mission, and strives to achieve the goals for which it was setup. The Treasurer duties include:

- Have supervision of all the Corporation's monies and securities and have access to regular books of account.
- Ensure Chief Executive Officer disburse the Corporation's funds in payment of the just demands against the Corporation or as may be ordered by the Board, taking proper vouchers for such disbursements; and
- Support the Chief Executive Officer to provide the Board with an account of financial conditions of the office properly required of him or her by the Board.
- To ensure that the organization complies with its governing document (by-laws), 501C3 law, company law and any other relevant company compliance
- To ensure that the organization pursues its objects as defined in its governing document
- To contribute actively to the Board of Directors in giving clear strategic direction to the organization, defining goals and evaluating performance against agreed targets
- To assess and manage risks
- To ensure the organization utilizes resources effectively
- To safeguard the good name and values of the organization
- To ensure the financial stability of the organization

Each Board member is expected to use any specific skill, knowledge or experience to help the organization achieve its goals. This will involve:

• Attending approximately four Board meetings per year via zoom; one of which is an onsite strategy day/Board meeting (usually combined with our annual Conference in November)
